## TAX ADVANTAGES OF THOUGHTFUL GIVING

Federal and state laws on income and inheritance taxes encourage charitable giving. All annual contributions to our campaign are tax deductible for those who itemize their deductions.

In addition to monetary commitments, we welcome contributions of appreciated securities, real property, or other valuables. The fair market value of securities or property is deductible. However, for substantial gifts of property, other than marketable securities, the IRS requires an appraisal.

Because each family situation is unique, we urge you to discuss your commitments within your family. You may also wish to discuss it with your financial advisor to see which plan would be most beneficial to you and to St. Clement. Whatever amount you decide to contribute to the campaign should be in response to God's gifts to you.

## MATCHING GIFTS

Many members of St. Clement are employees or retirees of companies which have a matching gifts program to Elementary Schools. A matching gift program allows a donor to double or even triple the size of the pledge.

Simply contact your personnel office for the appropriate form, complete the donor portion, and then forward the form with your pledge card to St. Clement. We will then complete the form, return it to the company and watch your generosity grow!

Parishioners may take advantage of this opportunity since a percentage of the campaign project is for the improvements to the computer lab and school building.
